Dear Residents and Families/Representatives,

Please accept this letter as our update on the status of COVID-19 in our facility.

We will continue to notify you through our website of any changes in visitation procedures and if we receive confirmation of new positive case in our facility. We will reach out to you individually if your loved one is displaying symptoms of COVID-19 or tests positive for COVID-19.

Visitation Status:

We are glad to announce we are open to window and lobby visits, and we will continue to keep you updated on our reopening plans as they are available to us by the State of Nevada. It is in the policy that you call the Receptionist to schedule window and lobby visits with your loved ones. Please observe the following facility guidelines that are put in place to help keep our facility COVID-19 free.

- **Visit times are as follows: Monday – Friday 9:00am – 4:00pm. Saturday and Sunday visits are 10:00am-4:00pm.**
- **Visits can only be scheduled with the receptionist.**
- **All visitors must check in with the receptionist, sign in, and take temperature in the facility lobby before your scheduled visit whether indoor or at the window due to tight guidelines. If at any time the visitor rules are not followed you may be asked to leave.**
- **All visitors must wear a mask and other proper PPE throughout the visit.**
- **No more than 2 visitors per visit, please call the Receptionist to see if accommodations can be made.**
- **All visits cannot exceed 1 hour to allow for proper cleaning before the next visit and ensure that you are on time.**
- **Visits are open to 16 and older only at this time due to vaccination availability.**
- **While visiting you must assure that social distancing will be followed and you must remain 6ft apart from your loved one.**
- **We will do what we can to ensure privacy, but staff will have to oversee visits to ensure core principles are followed.**
- **Please forward visitation guidelines to other loved ones, failure to follow the visitation rules may prevent you from visiting. We must follow our core principles.**
- **Any visitation requests called in over the weekend will need to be approved by the weekday Receptionist. You will receive a call if the request cannot be fulfilled.**

Activities:

We continue to have many activities in the facility for all residents to participate. There is a wide range of options from coloring to bingo and dancing! We want to ensure the residents are remaining safe, but still have a variety of activities to be a part of!

Facility Safety Precautions:

We continue to practice the enhanced safety precautions that are known to prevent the spread of COVID-19, such as only essential personnel are allowed inside the facility and we screen them for signs and symptoms of illness prior to entering. Our residents are continually monitored and staff are using PPE as recommended by the CDC. Staff is frequently reminded and encouraged to practice social distancing and to use hand sanitizer and frequently wash their hands when they are in the facility and out in the community. We ask them not to report to work if they have symptoms of illness.

Vaccination:

We have partnered with our pharmacy to continue vaccinating our staff and residents. The vaccines are available on Wednesdays. Starting this Friday, we will be distributing the Pfizer vaccine booster shots to staff and residents as they become eligible. We will continue to do this every Friday until everyone eligible has their booster shot. Any questions, please feel free to contact us.
