Dear Residents and Families/Representatives,

Please accept this letter as our weekly update regarding the status of COVID-19 in our facility. Since the onset of this virus, we have had 36 residents and 28 staff members test positive for COVID-19. Currently, we do not have any COVID positive patients residing in house, and any employees who tested positive were immediately sent home to quarantine, and will continue to do so until appropriate policies are undergone that will allow them to return to the facility.

As you might be aware, and as we have previously communicated, CMS has distributed guidance for nursing facilities to allow visitors. While we are so excited to for you to see your loved ones and to have you back at our facility, there are many factors that determine when a facility can open up for visitors, up to and including our county's COVID-19 positivity rate, residents' health status, or if there is a COVID outbreak in the facility. Please be assured we are working hard to create visitation plans that will allow you to visit your loved ones as soon as possible, but we need to make sure the visits can be done safely. We will let you know as soon as those plans are in place.

As always, we are working hard to keep everyone in our community safe and we will continue to practice the enhanced safety precautions that are known to prevent the spread of COVID-19, such as only essential personnel are allowed inside the facility and we screen them for signs and symptoms of illness prior to entering. Our residents are continually monitored and staff is using PPE as recommended by the CDC. Staff is frequently reminded and encouraged to practice social distancing and to use hand sanitizer and frequently wash their hands when they are in the facility and out in the community. We ask them not to report to work if they have symptoms of illness.

Please continue to check our website for weekly updates as well as notification of new cases. Please accept this letter as our weekly update regarding the status of COVID-19 in our facility. Since the onset of this virus, we have had 36 residents and 28 staff members test positive for COVID-19. Currently, we do not have any COVID positive patients residing in house. Our last positive COVID-19 case was September 19, 2020, and it has since been resolved. Additionally, we are continuing to conduct weekly testing within the facility, to ensure the safety of our staff and residents.

We are also happy to mention that, after what seems like forever, we are excited to welcome you back to our facility for visits with your loved ones! However, please understand visitations will be conducted very differently than in the past for the purpose of protecting our residents, and staff's safety, as well as your own. Therefore, please read below for some general visitation requirements and information that you should know prior to visiting your loved one.

Visitors will now be able to schedule an appointment with the Facility Receptionist for an in-person visit. Visits will occur as long as Clark County's positivity rate is below 10% and the facility has remained COVID-free for 14 days.

Currently, visitations are running Monday through Friday. They can be scheduled at 1PM, 2PM, 3PM, and 4PM. Visits will last 30 minutes, allowing the receptionist to sanitize and disinfect the visitation areas, and hugs and holding hands, unfortunately, will not be permitted.

As always, we are working hard to keep everyone in our community safe and we will continue to practice the enhanced safety precautions that are known to prevent the spread of COVID-19, such as only essential personnel are allowed inside the facility and we screen them for signs and symptoms of illness prior to entering. Our residents are continually monitored and staff is using PPE as recommended by the CDC. Staff is frequently reminded and encouraged to practice social distancing and to use hand sanitizer and frequently wash their hands when they are in the facility and out in the community. We ask them not to report to work if they have symptoms of illness.
