WEEKLY UPDATE

06/11/2020

Dear Residents and Families/Representatives,

As of today, 35 residents and 26 staff members have tested positive for COVID-19 in our facility. Currently, 16 residents are resolved, and 23 employees have returned to work. Numbers for in-house COVID cases have been steady since the last update, with one (1) resident in the observation unit and 4 residents in the COVID wing.

Our staff continues to practice the enhanced safety precautions we have previously reported to you through our website and we are closely monitoring the recommendations of our federal, state and local health officials regarding all aspects COVID-19 from mass testing to visitation recommendations.

In fact, as Nevada continues to loosen COVID-19 restrictions throughout the state, many people are asking when they will be able to visit their loved ones. At this time, the Centers for Medicare and Medicaid Services (“CMS”), the Centers for Disease Control (“CDC”) and our state health officials still recommend we restrict social visitation and only allow essential personnel in the facility. Please understand these restrictions are in place to reduce the risk of transmission of COVID-19 in our facility and to keep our residents safe.

We understand how difficult it has been to not see and visit your loved ones over the past several months and we appreciate your patience and understanding during this time. Until it is safe to allow visitors, please remember that we encourage you to stay in touch with your loved ones through FaceTime, emails, letters and phone calls. In order to facilitate an open line of communication with the family, we have been sending out letters every week with updates on the current situation within our facility. Additionally, our activities department has been facilitating daily FaceTime calls between residents and their family members. Please let us know if you are having trouble connecting with your loved one and we will be more than happy to facilitate your communication.

Please remember to check our website for updates. As always, we will notify you if we receive confirmation of a new positive case in our facility and we will reach out to you individually if your loved one is displaying symptoms of COVID-19 or tests positive for COVID-19. WEEKLY UPDATE

06/16/2020

Dear Residents and Families/Representatives,

Please accept this letter as College Park Rehabilitation Center's weekly update to keep you informed about the status of COVID in our facility and what we are doing to keep our residents and staff safe during the ongoing coronavirus pandemic.

As of today, 35 residents and 26 staff members have tested positive for COVID-19. Additionally, 19 of these residents and 24 staff members have had their cases resolved. We currently have only one COVID-positive resident in the facility. Three of our COVID positive residents from last week are now in our observation unit. We will continue to work hard and take all necessary steps to meet and maintain our goal of becoming COVID-free.

As a reminder, we continue to closely monitor and follow the recommendations of our federal, state and local health officials. Only essential personnel are allowed inside the facility and we screen them for signs and symptoms of illness prior to entering. Our residents are continually monitored and staff is using PPE as recommended by the CDC. Staff is frequently reminded and encouraged to practice social distancing and to use hand sanitizer and frequently wash their hands when they are in the facility and out in the community. We ask them not to report to work if they have symptoms of illness.

Please continue to check our website for updates. As always, we will notify you if we receive confirmation of a new positive case in our facility and we will reach out to you individually if your loved one is displaying symptoms of COVID-19 or tests positive for COVID-19.

WEEKLY UPDATE

06/05/2020

Dear Residents and Families/Representatives,

As we approach summer and states are slowly starting to reopen, we want you to know that the staff at College Park continues to work hard to prevent further spread of COVID-19 in our facility.

As of today, 35 residents and 26 staff members have tested positive for COVID-19 in our facility. Currently, 13 residents are resolved, and 21 employees have returned to work.

In addition to the increased safety precautions we have previously reported, we have created two separate COVID focused areas for residents. The back four rooms of A-Hall are for those who have tested positive for COVID-19, and the front four rooms are for observation of residents who are suspected of having the virus but still awaiting test results. The two units are separated by a plastic divider. As of today, we currently have **3** residents in the observation unit, and **4** residents in the COVID Wing.

As far as staffing, we have two sets of dedicated staff for these two units. The COVID positive staff remain within the unit, with their own break room and entryway. The COVID observation staff are similarly confined, but enter through the main lobby.

We are committed to stopping the spread of this virus in our community and we will continue to work with our federal, state and local health officials to implement all necessary protective measures.

Please continue to check our website for updates. As always, we will notify you if we receive confirmation of a new positive case in our facility and we will reach out to you individually if your loved one is displaying symptoms of COVID-19 or tests positive for COVID-19.
